### **KEY CONCEPTS**

- Focuses on classification, assessment criteria, and decision-making structure for how Buncombe County uses and disposes of land
- Policy needed for public awareness and uniformity of operations
- Process follows NC General Statutes
- Need determination was the motivation to get this policy in writing





### **ADDITIONAL CONTENT**

- Feasibility Analysis
- Land Disposition Review Panel
  - Planning, Legal, General Services, Recreation Services
  - Ad hoc reviews will be conducted
- After review, identify potential uses such as:
  - Affordable Housing
  - Recreation
  - County Facilities
  - Other Potential
- No identified potential  $\rightarrow$  Disposition process according to statute

### NCHFA LIHTC AWARDS

4% Tax Credit Awards: Lakeshore Villas & Vanderbilt Apartments

- 4% LIHTC = \$303.0 Million (\$33.0 Million to Buncombe)
- Units = 2,333 (143 in Buncombe)

#### 9% Tax Credit Awards: Star Point

- 9% LIHTC = \$31.0 Million (\$1.16 Million to Buncombe)
- RPP Loans = \$25.4 Million (\$1.2 Million to Buncombe)
- Units = 1,664 (60 in Buncombe)






#### **9% LIHTC AWARD**

#### Star Point (MHO, Inc.)

- Housing Credits = \$1,166,500\*
- RPP Loan = \$1,200,000
- Units = 60 Family





- Buncombe County Commitments = \$500,000 (AHSP General Funds)
- City of Asheville Commitments = \$850,000 (Asheville Housing Trust Fund)
- Asheville Regional Housing Consortium Commitments = \$0 (HOME)

\*Estimated LIHTC Equity at \$10,498,500 given on file proforma assumption of \$0.90 on the \$1.00.
