Meeting Minutes

Buncombe County Agricultural Advisory Board - Buncombe Soil & Water Conservation District 60 Lakeshore Dr., Weaverville, NC 28787 April 18, 2023, at 9:30 am

Meeting was called to order at 9:51am by Chair Steve Duckett.

Approval of the April 18, 2023, Meeting Agenda

> David Lee made a motion to approve the April 18, 2023, meeting agenda, seconded by Bruce Snelson, and the motion passed on the vote.

Approval of the March 21, 2023, Meeting Minutes

> David Lee made a motion to approve the March 21, 2023, meeting minutes, seconded by Wayne Welch, and the motion passed on the vote.

Bond Criteria Discussion

Staff presented the Board with some feedback that the BOC had on the Ag Advisory Board (AgAB) conservation easement criteria for the Open Space Bond. The BOC questioned the "development pressure" section of the AgAB criteria as they wanted to ensure that criteria didn't conflict with the affordable housing bond criteria. Staff explained that section of the criteria represents a small portion of the project selection and had been included initially because some grant agencies asked that question in the grant application. However, the question was removed from the bond project selection criteria.

The BOC also asked Staff to consider adding points to a project if additional funding had been leveraged. Staff mentioned that they added a question regarding leveraged funding to the AgAB criteria in lieu of the development pressure but wanted to point out that most farmers can't donate high percentages of their land value as it is generally their largest asset, so there may be equity issues surrounding preferencing parcels with high donation percentages. Mr. Duckett stated that his suggestion would be to weight that question lower and add weight to the soils section so that leveraged funding is considered but would not put a working farm with good soils at a disadvantage if the farmer was unable to donate a higher value. The Board agreed.

Lastly, the Board discussed and clarified wording in the easement flowchart of what "Up to 50% of easement value" meant. An agreement to clarify that statement in the flowchart was made so that it would read: "The Bond can fund up to 50% of the easement value after other funding sources have been explored/exhausted." The Board also discussed requiring landowners to donate 25-50% of the easement value in a bond-funded project to ensure fair and consistent compensation to landowners as has been done in the past.

> Bruce Snelson made a motion to approve the amended ranking criteria, seconded by David Lee, and the motion passed on the vote.

After speaking with the County Attorney, one of the options suggested was to take the easement projects to the SWCD board for approval and then taking it to the Ag Advisory Board – just so that the SWCD is familiar with the easement project that they will hold if it is approved. The AgAB suggested creating a MOU between the two boards that would be renewed annually instead of needing the SWCD Board to approve each project as the AgAB was tasked with the approval process. Staff stated they would take the suggestion to the County Attorney.
